

REALTIME RISK ASSESSMENT LIMITED ON-LINE SOFTWARE
LICENCE AGREEMENT

IMPORTANT: Please read the terms and conditions of this licence agreement carefully before using the software. Realtime Risk Assessment Limited is willing to license the software to you as the individual, the company, or the legal entity that will be utilizing the software (referenced below as “you” or “your”) only on the condition that you accept all of the terms of this licence agreement. This is a legal and enforceable contract between you and Realtime Risk Assessment Limited, by clicking the “accept” or “yes” button or otherwise indicating assent electronically, you agree to the terms and conditions of this agreement. If you do not agree to these terms and conditions, click the “i do not accept” or “no” button or otherwise indicate refusal and make no further use of the software.

1. Licence:

The on-line access to the software and any documentation that accompanies this licence (collectively the “Software”) is the property of Realtime Risk Assessment Limited, or its licensors, and is protected by copyright law. While Realtime Risk Assessment Limited continues to own the Software, You will have certain rights to use the Software after Your acceptance of this licence. This licence governs any releases, revisions, or enhancements to the Software that Realtime Risk Assessment Limited may furnish to You.
